

MINIBUS USAGE CONDITIONS

(MUST BE RETURNED IN FULL PRIOR TO USE OF THE MINIBUS AND COLLECTION OF KEY)

This minibus is managed by NRG Landscaping Services Limited which is a privately owned company based in Essex. The founder and Managing Director, Nick Green has wanted to provide a community-based minibus for many years and through a private donation has been able to acquire a minibus LDC Maxus, Registration P8 NRG

The minibus is available for use within the community of Essex and particularly the Southend area.

Please note that this minibus is not for rent or hire, however we would expect a charitable donation be made to Rochford Community Church Trust details of which are below

Please note that if you are a UK Tax Payer then we may be able to claim Gift Aid against your donation

Donations shall be made to Rochford Community Church Trust – Sort Code 20-79-73 Account No 60756164

Terms of usage can be found overleaf, and the authorized driver shall need to hold a full UK Driving License and be over the age of 30. A photocopy of the driving license shall need to be emailed to nick@nrghandscaping.com prior to usage

The use of the minibus shall be in line with all regulations stated within the Highway code and all speed restrictions shall be adhered to. Any traffic violations and payment thereof received during the use of the minibus shall be borne by the user stated below.

A refundable deposit of £200 is required 7 days prior to use, via BACS, to **Sort Code 20-19-97 Account Number 20813761**, with notification that this has been paid to nick@nrghandscaping.com , when using the minibus with the permission of Nick Green (Owner) Company **NRG Landscaping Services Limited**. The deposit will be returned once an inspection of the minibus has been carried out post use.

Assuming the minibus is returned in the same condition it was released the deposited will be returned within 3 to 5 days.

Regarding fuel we would expect the user to replenish the fuel used and record the opening and closing mileage of the minibus prior to and after use. We have a 'meet and greet' Manager, Steve Smart who will meet you at the minibus compound in Rawreth to carry out a condition inspection prior to and after use. The minibus is expected to be returned in the same condition as it was released to the user. Any damage or items that require attention prior to being used by another person shall be reported. The key shall be returned to our 'Meet and Greet Manager, Steve Smart or to the following address:-

Terms and conditions for hiring a minibus can include:

- ⌚ **Driver's responsibilities:** Drivers must inspect the vehicle before each use, and note any damage. Drivers must not drive under the influence of drugs or alcohol.
- ⌚ **Passenger conduct:** Passengers must wear seat belts and not smoke or vape in the minibus. The driver may remove passengers who are unsafe or break the law.
- ⌚ **Vehicle damage:** The signed user is responsible for any damage caused to the vehicle by passengers.
- ⌚ **Itinerary:** The user must adhere to the agreed itinerary times.
- ⌚ **Vehicle availability:** The company might consider providing a different vehicle than the one agreed upon if the original is unavailable.
- ⌚ **Driver details:** The driver's details including Driving Licence shall be provided 1-2 days before the journey, electronically to nick@nrghandscaping.com.
- ⌚ **Age restrictions:** NRG require all hirers to be over 30 years of old. Proof of age will be required when pick up the minibus.
- ⌚ **Driving Habits:** The minibus shall be used in a responsible manner and if this is found not be the case then the use of the vehicle to the user on future dates will not be allowed
- ⌚ **Deposits:** We will require a deposit of £200 that is refundable if the journey is cancelled. A deposit shall also be required for the use of the minibus which will be returned once an inspection of the vehicle has been carried out by the NRG Team
- ⌚ **Refunds:** We are happy to refund your deposit if the booking is cancelled as long as we receive 7 days' notice, but it may be subject to conditions.

⌚ **Damage:** Any damage to the minibus shall be immediately reported to the owner, NRG Landscaping.
